Season's Greetings!

In continuation of our mail letter Ref. No. 8/ SISSTA/ISC-Technical Tour, dt. 16.02.2024, 11.03.2024 & 01.04.2024, it is with great pleasure that we extend an invitation to you and the members of SISSTA to participate in the International Sugar Conference and technical tour which will be organized by **8th IAPSIT International Sugar Conference (ISC-2024) at Quy Nhon, Vietnam from 16th - 19th September, 2024.**

The proposed conference on Building a Resilient and Sustainable Global Sugar & Bio-energy Industry- Transforming ASEAN Sugar Sector will be attended by around 300 delegates from 25 sugar producing countries. The main focus of this conference will be on the sustainability of sugar industry in the present scenario with a greater thrust on boosting sugarcane productivity through climate resilient varieties and agro-technologies, advanced farm mechanization, diversification and value chain management. Besides conference, participants will visit a sugar mill farm and also interact with the important persons of ASEAN Sugar sector. On our way back, a special study-cum-sight seeing tour of Ho Chi Minh City (Saigon) is proposed, delegates will interact with the Scientists of Sugarcane Research Institute, Vietnam; President Vietnam Sugarcane & Sugar Association, visit Museums and important places of city.

In view of the theme and relevance of this conference to our sugar units, it is proposed that a delegation of SISSTA members shall be visited Vietnam and attend the International Sugar Conference-cum-Technical Tour to have an exposure of emerging technologies contributing to sustainability of sugar sector. The tentative schedule of the delegation will be as follows:

- Arrival in Ho Chi Minh City/Quy Nhon : 15th September, 2024
- Attend Conference in Quy Nhon : 16th - 19th September, 2024
- Departure from Quy Nhon & Arrival in Ho Chi Minh City: 20th September, 2024

Delegation Fee Details:

- a. Registration fee is Rs. 70,000/- per member. (Registration package includes boarding and lodging for 4 nights in Seagull / Anya hotel (16th -19th September, 2024), local airport transfer, morning and afternoon tea, coffee, all meals, welcome and gala dinner, conference materials, publications and IAPSIT/SSRP membership fee). Approximate to & fro air ticket will be Rs. 30,000/- extra.
- b. Registration fee for Spouse & Children – Rs. 35,000/- per person. (excluding accommodation & air ticket)
- c. Registration fee is Rs.45,000/- per member (excluding accommodation & air ticket). Other T&C will remain the same.
